### MEMORANDUM OF ASSOCIATION

- The Name of the Company is CENLUB INDUSTRIES LIMITED.
- The Registered office of the Company will be situated in the State of Haryana.
- The objects for which the Company is established are:-
- THE MAIN OBJECTS TO BE PURSUED BY THE COMPANY ON ITS INCORPORATION ARE:
  - To manufacture, produce, refine process, assemble, mine or otherwise acquire, invest in own, hold, use, lease mortgage, pledge, buy, sell, exchange, distribute, assign, transfer or otherwise dispose of, trade, deal in and deal with, import and export any and all classes and kinds of lubrication systems, pumps their sub-assemblies, accessories and any and all classes/types of engineering parts, source materials, ingredients thereof, and any and all kinds of product of which any of the foregoing constitute an ingredient or in production of which any of foregoing is used.
  - To acquire and take over as a going concern the firm M/s Cenlub Engineers situated at Faridabad with all or any of its assets including land and building and liabilities of the firm on such terms and conditions as may be mutually agreed upon the said firm shall cease to exist after such takeover is done by the company after incorporation.
  - To carryon the business of share brokers and to underwrite, sub-underwrite, to invest in, and acquire and hold, sell buy or otherwise deal, in shares, debentures, debenture-stock, bonds, units obligations and securities issue-'or guaranteed by Indian or Foreign Government, State, Dominions, Sovereigns, Municipalities, or Public Authorities or Bodies and share, stock, debentures, debenture-stock bonds, obligations and securities issued and guaranteed by any company, corporation, firm or person whether incorporated on established in India or elsewhere.
  - To carryon business of exporters, importers, clearing agents, consultants and liasioning relating thereto.
  - To manufacture and deal in all types of machine tools and accessories and to act as importers, exporters, dealers, consultants, brokers, agents, mechanical engineers of engineering products, machine tools and their allied products.
